As an advocate of Georgia presented more than 150 cases before the European Court of Human Rights and United Nations treaty bodies; gained a particular reputation in the application of international standards to criminal law and procedure, all aspects of litigation and acted in cases

Most notable cases in the Strasbourg Court include:

Georgia v. Russia (1) (application no. 13255/07) — the case, which essentially concerned the existence of an administrative practice involving the arrest, detention and collective expulsion of Georgian nationals from the Russian Federation in the autumn of 2006, was accomplished successfully. In the Grand Chamber judgment the European Court of Human Rights held that there had been: a violation of Article 4 of Protocol No. 4 (prohibition of collective expulsion of aliens) of the European Convention on Human Rights; a violation of Article 5 § 1 (right to liberty and security); a violation of Article 5 § 4 (right to judicial review of detention); a violation of Article 3 (prohibition of inhuman or degrading treatment); violations of Article 13 (right to an effective remedy) in conjunction with Article 5 § 1 and with Article 3; and a violation of Article 38 (obligation to furnish all necessary facilities for the effective conduct of an investigation).

Georgia v. Russia (II) (application no. 38263/08) - the Court declared the application admissible by a decision of 13 December 2011. The application was lodged in the context of the armed conflict between Georgia and the Russian Federation in August 2008. The applicant Government alleges that, in the course of indiscriminate and disproportionate attacks by Russian forces and/or by the separatist forces under their control, hundreds of civilians were injured, killed, detained or went missing, thousands of civilians had their property and homes destroyed and tens of thousands of people were forced to leave Abkhazia and South Ossetia. In their submission, these consequences and the subsequent lack of any investigation engaged Russia's responsibility under Articles 2, 3, 5, 8 and 13 of the Convention, Articles 1 and 2 of Protocol No. 1 and Article 2 of Protocol No. 4.

Ashlarba v. Georgia (application no. 45554/08) - the case concerned alleged structural deficiency in the law which punishes individuals for their membership of a criminal syndicate and which was introduced in Georgia in 2005 as part of a legislative package aiming to fight against the criminal underworld and organized crime. In the Chamber judgment the European Court of Human Rights held that there had been no violation of Article 7 (no punishment without law) of the European Convention on Human Rights.

Natsvlishvili and Togonidze v. Georgia (application no. 9043/05) — in this case the Court for the first time examined in detail the compatibility of plea-bargaining arrangements with the right to a fair trial. The European Court of Human Rights held: that there had been no violation of Article 6 § 1 (right to a fair trial) of the European Convention on Human Rights and Article 2 of Protocol No. 7 (right of appeal in criminal matters) to the Convention;

Khoniakina and others v. Georgia (application no. 17767/08) – the case concerned the retirement pension of a former Supreme Court judges, which had been modified under a retroactive legislative amendment. In the judgment the European Court of Human Rights held that there had been: no violation of Article 6 § 1 (right to a fair trial) of the European Convention on Human Rights; and, no violation of Article 1 of Protocol No. 1 (protection of property) to the Convention.

Goginashvili v. Georgia (application no. 47729/08) - in this case the Government of Georgia demonstrated before the Court that complaint procedure system introduced in Georgian prisons in 2010 was effective for the purposes of Article 35 of the convention. On the merits, the Court found there had been no violation of Article 3 of the Convention as the prison authority had provided the applicant with prompt and systematic medical care.
