- Main field(s) of study for the qualification: European Studies. Students starting the programme before 2012/13 opt 2.2 between the track European International Politics, the track European Politics and Administration, or the track Europe in a Global Perspective. As of 2012/13 the student opts between the three specialisations; specialisation European Politics and International Relations, specialisation European Public Policy and Administration, or specialisation Europe from a Global Perspective. The student's track or specialisation is listed on the enclosed "List of Exam Subjects".
- Name and status of the awarding institution: Universiteit Maastricht (Maastricht University); public research 2:3 university, state recognized.
- Name and status of institution administering studies: Universiteit Maastricht (Maastricht University); public research university, state recognized.
- Language(s) of instruction: English. 2,5

#### Information on the level of the qualification 3.

- Level of qualification: Second cycle National Qualifications Framework for Higher Education, Level 7 EQF for LLL. 3.1 3.2
- Official length of programme: One year; 60 ECTS credits.
- Access requirements: Bachelor's degree in European Studies of the Faculty of Arts and Social Sciences, Universiteit Maastricht; or a relevant (professional) Bachelor's degree, if deemed necessary followed up by of the so-called "Premaster" of 30 ECTS credits; and sufficient proof of proficiency in the English language: an IELTS score of at least 6.5, a TOEFL score of 575 (paper-based), 233 (computer-based) and 90 (internet-based), a Cambridge Proficiency Certificate (grade A, B, C) or a Cambridge Advanced Certificate (grade A, B, C+).



# Information on the contents and results gained

- 4.1 Mode of study: Full-time.
- Programme requirements: This one-year, international master's programme is an advanced programme, building 4.2 on the Bachelor in European Studies. The programme is situated within the broad and expanding field of interdisciplinary European Studies, focusing on European integration and the European Union in its political, cultural, historical, international and other relevant context. It offers the students the opportunity to specialize by opting for a) an international politics track (focusing on the EU's external policy in its international context), b) political-administrative track (focusing on the political and administrative aspects of European policy-making and the interaction between different levels: European, member state, and civil society) and c) a track that examines Europe in a global perspective with regards to the globalisation process and the institutions of international governance. The combination of theoretical expertise, project work and skills training aims to prepare students for an array of policy-oriented professions with a strong European or international dimension.

Educators uniformly comment on the great difficulty in obtaining 9s and 10s and the respectability of 6s. There is also agreement that an 8 represents a high level of achievement, while grades 6 and 7 generally account for the majority of passing grades awarded.
